

The purpose of the Investment Conference was to expedite the implementation of the SADC Industrialisation Strategy and Roadmap (2015-2063) and identify Industrialisation projects for joint implementation by the public and private sectors in SADC Member States. The conference offered a platform for local, regional and international investors to explore potential investment opportunities within the SADC region, network, establish collaborations and showcase transformative investments projects. The conference was attended by investors from the region and beyond setting the tone for further engagements. OFFICIAL OPENING DAY

The 2024 7th SADC Industrialisation Week going under the theme ***Promoting Innovation to unlock opportunities for Sustainable Economic Growth and Development towards an Industrialised SADC*** was officially opened on the 31st of July 2024 by His Excellency the President of the Republic of Zimbabwe and the incoming Chairperson of SADC, Dr. E.D. Mnangagwa at the Harare International Conference Centre in the Main Auditorium. The Official Opening Ceremony was attended by more than 500 delegates comprising foreign and local investors, captains of industry from various member states, diplomats, Ministers (local and foreign), private sector, development partners, business people and at least over 100 members from the press corp. The event was a resounding success and was broadcast live to a viewership of over 13 million Zimbabweans and many more viewers from the region and beyond. During the Opening Ceremony, His Excellency the President of the Republic of Zimbabwe and incoming SADC Chairperson urged Member States to embrace innovation to boost industrial productivity and competitiveness. He also underscored that to ensure the successful implementation of the SADC Industrialisation strategy and Roadmap 2015-2063, SADC Member States must increase investments in technology, innovation and research and development.

The President also said that “given the vast natural resource endowments and youthful population in the region, it is a misnomer that we continue to lose substantial revenues through exporting unprocessed goods”. He added that, “modernization and Industrialisation of our economies is no longer a luxury but a matter of necessity for the future we all want and deserve”.

President Mnangagwa also called for member states to propel the Industrialisation initiative and shun working in silos. He said all national development strategies must be in sync with the broader development agenda.

The #SIW2024 had a record breaking cumulative total of 2016 people accredited and from this total, 251 were members of the press.

Precabe Farm

Champion Foods



Champion Foods (Pvt) Ltd (Harare): is an indigenous Zimbabwe-owned milling company that was established in 2023. Champion Foods has made significant investments in its facilities, with more than US\$10 million allocated to the establishment of various plants and silos. These include a maize meal plant, a wheat plant, and storage silos. The company boasts an impressive production capacity of 500 tonnes per day for maize meal and 200 tonnes per day for wheat. Currently, the company employs a total of 120 individuals, of which 50 are working on contractual agreements.





Company Visits:

Dairibord Holdings Limited



Dairibord was established in 1952 as a state-owned parastatal called the Dairy Marketing Board. The company underwent a successful commercialisation process, and was incorporated in 1994. Following this milestone, it achieved a historic listing on the Zimbabwe Stock Exchange in 1997, becoming the first state-owned enterprise to do so.

Dairibord has established itself as a leading manufacturer and marketer of high-quality milk, food and beverage products within the Zimbabwean market and beyond. Its diverse portfolio encompasses milks, including the popular Chimombe, Steri milk and Lacto cultured milk brands. Dairibord extends its expertise beyond dairy, offering a selection of food and beverage products. Notably, its beverage portfolio includes market leaders such as Pfuko maheu, Cascade and Fun n Fresh dairy fruit juices.





Company Visits:

Davipel Holdings (Pvt) Ltd



Davipel Holdings (Pvt) Ltd (Harare) is an indigenous dried foods and Stock Feeds manufacturing company established in 2002 with the objective of supplying quality dried foods and quality Stock feeds to both local and regional markets. Davipel Holding's product lines are traded under the following brand names; Jumbo, Diggles, Sunny, Royal under Food Items and Agrimilling for the Stock Feed lines.

The Holdings Company is comprised of Four Divisions namely Davipel Snacks, Agrimilling Milling, Agrimilling Stock Feeds and Davipel Freight Divisions.

The Holdings Company has expanded from simply Davipel Snacks through backward integration and established Agri-milling Milling Division in 2018 with the core objective of supplying Davipel Snacks with its main raw material Maize Grits. The Agrimilling Plant is a Grits Plant that however produces a variety of other product lines namely Samp, Corn flour, Roller Meal, Refined Meal, and Germ Meal.

Davipel Holdings has a new stock feed plant worth Euro €4 million and can produce 10 MT per hour with the latest technology. The plant has 2 silos which have a capacity of storing 4 000MT each. The company currently employs 450 people.





Company Visits:

Delta Beverages



Delta Beverages (Harare): The company traces its roots back to 1898 when the foundation stone was laid by the Salisbury Lager Beer Brewery and Ice Factory. It was first listed on the Stock Exchange in 1946 as Rhodesian Breweries Limited. The company later changed its name to Delta Corporation in 1978.

Delta invested more than US\$70 million in new plants and projects, including Lager Beer US\$15 million; Chibuku Super US \$20 million; SBS PET Line US \$10 million; AFDIS US \$1 million; Containers US \$15 million; and Vehicle Fleet US \$5 million.

Delta Beverages employs +/-7,000 people directly in the region and +/-5,000 employees in Zimbabwe.





Company Visits:

Dendairy



Dendairy was established in 2004 after identifying that there was demand in Midlands for locally produced dairy products. Strategic investments were made into the Company to a total cost of \$16 million with the introduction of the UHT sachets plant, Tetra Pak box plant, the factory continually being upgraded, and putting into place cost saving measures has all gone a long way in making the business evolve on a sound base.

Dendairy products are now listed in all major retailing chains and has engaged distributors who service the entire country from Beitbride to Vic Falls, Kariba to Mutare and Masvingo. The primary route to market is retail, wholesale and the informal sector.





Company Visits:

Dinson Iron and Steel Company



The company was established in 2021. Dinson, one of the three local subsidiaries of China's Tshingshan Holdings Limited has invested US\$1.5 billion in an Integrated Iron and Steel Plant in Manhize near Mvuma. The company expects to produce 600 000 MT of steel per annum in the first phase which would rise to 1.2 million MT in the second phase, 3.2 million MT in the third phase and 5 million MT in the final phase, employing more than 1 700 people.

The group has two high-carbon ferrochrome furnaces in Selous in Mashonaland West province and a 150,000 MT coke battery in Hwange's Mpongola village. Through its subsidiary, Dinson Colliery, Tsingshan is building a 300,000 MT per year coking plant, Zimbabwe's largest and most advanced coke oven. On the 11th of June 2024, the company fired up its blast furnace as their cast iron machine commenced the production of the first batch of pig iron.



Company Visits:

Irvine's



Irvine's Zimbabwe is an integrated poultry operation and supplier of Day Old Chicks, Broiler & Layer Feed. The company's breeder farms and hatcheries are located across Zimbabwe, Botswana, Tanzania, Kenya and Mozambique, producing an average of 2,000,000 day-old broiler chicks every week. Irvine's produces an average of 3,800 tonnes of finished feed every single week. The company's facilities in Zimbabwe process an average of 280,000 frozen birds every week. Layer Farms in Zimbabwe produce 6,500,000 table eggs every week.





Company Visits:

Kefalos



Kefalos Cheese Products is a leading dairy foods manufacturer in the Southern African region, providing its customers with healthy and innovative products. The company was established in the 1970s and is based in the Marirangwe area, Mashonaland East.

The company continues to grow from strength to strength by pioneering new products while meeting top international standards and local needs for nutritious and healthy dairy produce. Kefalos provides Zimbabwe, and the Southern African region, with a wide range of high-quality cheese, ice cream, yoghurt, and various other dairy and non-dairy products.

Kefalos employs a diverse workforce who are mainly drawn from the surrounding communal area, whilst sourcing fresh milk used in production from local dairy farmers.





Company Visits:

Khayah Cement Limited



Khayah Cement Limited (Harare): The company started operating as Khayah Cement on 1 December 2022, having been formerly known as Lafarge Cement Zimbabwe. The company manufactures and distributes cement and allied products for the building industry. The company has a staff complement of 336 and is currently operating at 49% capacity utilization.

Since 2019, the company has invested over US\$ 25 million. Khayah Cement has a new vertical cement mill, worth US\$11 million, boosting its milling capacity to 1 million MT and enhancing its ability to supply high-strength cement at a lower cost.





Company Visits:

National Foods (Pvt) Ltd



National Foods (Pvt) Ltd (Harare) is one of the largest food manufacturers in Zimbabwe and was established in 1920. The company produces a wide variety of basic foods, such as maize meal, flour, cooking oil, margarine, rice, salt, snacks, biscuits, pasta, sugar beans, popcorn and cereal.

The net asset value of the company is US\$106.6 million as at June 2023. Over the past two years, the company has invested about US\$26.5 million in its breakfast cereal plant, biscuit plant, pasta plant, and flour mill. The company currently employs 1,762 people.

Seed Co



Seedco (Harare): The company was founded in 1940 by a Cooperative of Zimbabwean farmers. It has grown to become a Pan-African business that develops, breeds, and supplies certified seed species with a focus on hybrid maize, wheat, soya bean, beans, rice, potatoes, sorghum, cotton, and vegetables. The seeds are grown from parent seeds under contract farming by an established network of seed producers.

The company commissioned a US\$13 million drier with a capacity of 5,000MT this year, 2024. The company is well known for its ability to develop seed solutions ideal for the different ecological zones of Africa through robust research and development programmes.

Zimplats

Zimplats is a member of Impala Platinum Holdings (Implats), a leading globally integrated producer of platinum group metals (PGMs). Its operations started in Zimbabwe in 2001. They mine and process high-quality metal products safely, efficiently, and responsibly from a competitive asset portfolio. Zimplat's operations are geographically diverse, with all the operating mines and three concentrator plants located in Ngezi, while the other concentrator plant and a smelter are located in Selous – all along the Great Dyke in Zimbabwe – one of the most significant PGM-bearing ore bodies in the world.
