# MONITORING, EVALUATION AND REPORTING (MER) OF OVC AND YOUTH FORUM 17-19 MARCH 2015

The SADC Secretariat in collaboration with Swiss Agency for Development and Cooperation (SDC); Save the Children International (SCI); Regional Psychosocial Support Initiative (REPSSI); MiET Africa, and Regional Inter Agency Task Team on Children and AIDS (RIATT) will convene a Monitoring, Evaluation and Reporting (MER) of Orphans and other Vulnerable Children (OVC) and Youth Forum from 17-19 March, 2015 in Gaborone, Botswana.

The purpose of the forum is to facilitate stock taking and planning among Member States sectors and stakeholders responsible for OVC and youth in preparation for the implementation of the initiative to "Strengthening MER of OVC and youth in SADC".
