FCPF Carbon Fund operational

The Carbon Fund of the Forest Carbon Partnership Facility (FCPF), managed by the World Bank, has become operational and will finance verified emission reductions from REDD+ programmes. After going through the REDD+ Readiness process, five countries do now qualify for payments from the new fund. A total of USD 215 million will be available from the Carbon Fund of the FCPF. CIFOR study investigates links of mitigation and adaptation in forests

A new study by the Centre for International Forestry Research (CIFOR) in Latin America suggests that adaptation activities can contribute to the success of mitigation activities as well. So far, the two concepts have been treated separately in the international debate. An integrated approach of adaptation and mitigation would have serious implications for REDD+ projects, potentially increasing sustainability and funding options.
