SADC Water Ministers approve Climate Change Adaptation Strategy for the Water Sector

At their recent meeting in Maseru, Lesotho, SADC Ministers Responsible for Water approved the Climate Change Adaptation (CCA) Strategy for the water sector, which aims to improve climate resilience through the strengthening and adaptation of water resources development and management in Southern Africa, and promotes the adoption of a multi-dimensional approach to climate change adaptation. To assist African countries to prepare and understand NAMAs, the African Development Bank held a training workshop in July that focused on capacity building to design and implement NAMAs. A total of 24 countries participated in the training, 11 of which have since submitted their NAMAs, and 13 receiving further support from the AfDB for developing national frameworks and strategies.
