You mention on premise or Hybrid but with signing solutions the service is SaaS– Data need not sit in the cloud and can be removed onto your document management solution. On- premises proved to be very costly, and DocuSign are discontinuing the on-premises module going forward.	Refer to requirement number 11 The eSignature solution being proposed must be able to be hosted on premise at the SADC Secretariat <i>or</i> <i>provided as a cloud-based</i> or hybrid solution
