Recommendations for a potential regional programme in support of the implementation of the SADC Digital Transformation Strategy (SADC DTS)





Recommendations for a regional program supporting the implementation of the SADC regional digital strategy

This document proposes a list of potential **short-term studies and other initiatives that can build the foundations of a future regional program** in support of the implementation of the SADC regional digital strategy to be co-financed by EU NDICI and other funding schemes proposed by international cooperating partners and international financing institutions.

This DTS support program is composed of 23 regional studies and initiatives that are the initial building blocks of the SADC DTS implementation roadmap, fully aligned with the 7 strategic interventions described in the SADC DTS draft/blueprint shared in early October 2022.

These regional studies and initiatives could be supported or co-financed either by the EU through its different instruments, such as the NDICI regional MIP 2021-2027, by EU member states or by other technical and financial partners. Some key EU partnership instruments and a relevant World Bank program have been identified and described in the situational analysis report of July 2022. Other key potential support partners are mentioned below for each study/initiative. It is noted that it is highly recommended to involve Private Sector representatives (at investment levels but also at strategic mapping exercises level), and that the D4D Hub¹ platform provides an excellent opportunity to engage, not only with European MS / TEI flagged initiatives, but also into partnerships with the private sector, academia and CSOs.

The **recommended roadmap** for the SADC secretariat to **mobilise resources and support** for this program is to:

- Complete the first review process of the draft SADC DTS with member states and validate (or amend) the proposed strategic interventions. If the DTS priorities and strategies are amended, then this list of studies and initiatives should also be modified to reflect the updated priorities.
- 2. Review and validate the list of studies and initiatives proposed below based on what was further approved ensuring that the proposals are well aligned with the latest approved SADC DTS, and that the resources and timeframe estimated are realistic to achieve the outputs.
- 3. Identify or **assign an "ownership"** for each study or initiative (determine who will be in charge of managing and following up on the implementation of recommendations and designs) and the **steering and coordination mechanisms**, that should also be aligned with the proposed DTS implementation institutional arrangements.
- 4. Convene roundtables with the technical and financial partners (including EU, its MS agencies, International Financial and Development Finance Institutions, technical UN agencies, multi-laterals, regional pan-African initiatives, etc) and present these studies and initiatives to assess their interest in supporting and/or co-funding them.

This fourth point (round table with technical and financial partners) should include:

a. A **specific round table with the EU and MS agencies** to be launched in the frame of the <u>D4D Hub - Africa branch</u>. Also Important to involve together **with the regional EU office for SADC**, the main commission DGs (INTPA, Connect, etc), their thematic and regional desks (INTPA F5, A2) as they manage

technical assistance facilities (TAFs) and **the SADC region EU delegations**. These meetings should also include an exercise aimed at mapping the main programs on digital collaboration between AU and EU (PRIDA programme, EGEE-ICT program, and other relevant EU-AU initiatives etc).

- b. Another round table with **larger participation would include WB, AfDB, USAID**, the New Partnership for Africa's Development (NEPAD) Agency, JICA, KOICA, and other international key players active in the relevant sectors.
- c. And organise **thematic round tables for specific areas** with specialised thematic agencies and alliances such as GIGA², ITU Partner2Connect Digital Coalition, UNESCO, UNIDO, UNCTAD, UNEP, FAO, etc.

The following points are pivotal to the successful implementation of the 23 stand-alone studies and initiatives, and have to be mainstreamed through all those initiatives that will be implemented with the support of different potential partners:

- the SADC DTS provides the strategic framework and ensures the articulation, synergies, continuity, and future impact of all these 23 stand-alone studies and initiatives
- SADC and their MS have full ownership and will ensure articulated implementation of this DTS support program
