In addition to producing the 2025/2026 rainfall season outlook, SARCOF-31 provides a platform to validate the SADC Multi-Hazard Early Warning and Action System, and showcase tailored climate services for agriculture, water, energy, health, disaster risk reduction, and other critical socio-economic sectors.

WMO is proud to be a long-standing partner of the SADC region. Through the **ClimSA Programme**, WMO has supported:

- Building technical capacity for seasonal forecasting, downscaling, and impact-based services;
- Establishing Regional Sectoral User Interface Platforms (RSUIPs) for co-production of advisories;
- Advancing digital transformation and data sharing through WIS2.0 and related innovations; and
- Mobilizing partnerships for the **Early Warnings for All (EW4All) initiative**, ensuring no community is left unprotected.

Here in Zambia, WMO is honoured to continue supporting the Government's leadership on EW4All. Later this month, on **25–26 September 2025**, Zambia will host the **national launch of the EW4All initiative**, prepared in collaboration with the African Union Commission, the UN Resident Coordinator's Office, national pillar leads, and UNDRR. This launch marks an important step in operationalizing the global vision of universal protection at the national level, and WMO is proud to contribute to this milestone through technical support and dedicated expertise.

We are often reminded that hazards and disasters collaborate more effectively than many of our partners. Platforms such as SARCOF give us the space to outpace that collaboration—by working together across borders, sectors, and institutions—to foster resilience and protect our communities.

As WMO Secretary-General, Prof. Celeste Saulo, has reminded us:

"Early warnings are not a privilege; they are a human right. Protecting every community with timely and accurate warnings is both a moral and a development imperative."

In this spirit, SARCOF-31 gives us an opportunity to advance three shared priorities:

- 1. **Science and Services** Applying cutting-edge science and digital innovation to ensure forecasts are reliable, actionable, and user-oriented.
- 2. **Partnerships and Co-production** Strengthening collaboration among NMHSs, regional centres, sectoral ministries, humanitarian actors, and communities.
- 3. **Sustainability and Financing** Securing investments to implement the **SADC Early Warning for All Roadmap**, institutionalizing climate services that are inclusive and resilient.

Colleagues, as we deliberate over the coming days, let us reaffirm our collective commitment to saving lives, protecting livelihoods, and strengthening resilience across Southern Africa.
