## **B. KEY TALKING POINTS**

### **1. RE-EMPHASIZING OCHA, UNDAC, AND SADC ERT COLLABORATION:**

- As was stated at the opening of the course, OCHA's support to the SADC ERT is in line with existing global OCHA and UNDAC practices and experiences in supporting capacity building of regional organizations.
- As I indicated, our support to SADC is similar to the support we have provided to the ASEAN-Emergency Response and Assessment Team (ASEAN-ERAT) and the Caribbean Disaster Emergency Management Agency (CDEMA) for the Caribbean Community (CARICOM), and there are discussions with ECOWAS in West Africa for future collaborations, just to mention a few
- The Support builds on the success stories of RECs in Asia and the Caribbean, where RECs are managing disaster preparedness and response systems based on OCHA's past capacity investments. This frees OCHA resources to focus on other key priorities.

### **2. SADC SHOC AND SADC ERT RESPONSE COMPLEMENTARITY AND INTEROPERABILITY WITH OCHA AND UN RESPONSE:**

- As I indicated during the course opening, the SADC ERT course is largely based on UNDAC, which is a tried and tested global Emergency Response system with 32 years.
- I am pleased the RC/HC for Zimbabwe is here with us, as you know, the UNDAC support is either requested by the Government of the RC/HC, and UNDAC teams normally have a matrix reporting line to the Government and the RC/HC during deployments.
- There are aspects of contextualization that are being done and will continue to be done to have SADC ERT develop a fully functional, unique system.
- Given the current context where resources are limited, SADC ERT responses, which may include responses to localized emergencies within SADC Member States, mean OCHA can, in the future, save its scarce resources, knowing that SADC ERT/SHOC response and coordination capabilities resulting from this contribution will fill the gap that would otherwise be expected to be covered by OCHA.
- OCHA's role as a global emergency coordination agency will now be made easier and more efficient, given that SHOC/ERT assessments, coordination, and responses will embrace to a larger extent the OCHA and UNDAC standards and be aligned to core humanitarian principles and reporting arrangements.

- In large-scale responses within the SADC region, OCHA and other international response teams will work together with SHOC/ERT teams, and since they are trained based on UNDAC methodology, there will be interoperability across the response teams, which is critical for effective assessment, coordination, response, and reporting.
