Purpose: The purpose of this Addendum is to communicate changes to the data sheet (clauses ITB 4.3 & 4.4). The Addendum clarifies that, Financial Proposals are not to be submitted at this stage. Bidders who meet the minimum technical score of 70 points will be requested to submit Financial Proposals at a later stage. Further, the Addendum clarifies that bidders who submit Financial Proposals at this stage shall be disqualified.

Prospective Consultants shall review the Addendum requirements in detail and incorporate any effects the Addendum may have in their proposals.

Note: Please take note of the following changes to the data sheet. ITB 4.3 and ITB 4.4 clauses have been changed in their entirety to read as follows:
